## Rock of Ages Corporation Sold To Swenson Granite Co.

On February 22, 1984, the John Swenson Granite Company, Inc., purchased the entire holdings of the Rock of Ages Corporation and all of its foreign and domestic subsidiaries.

Kurt M. Swenson, President and Chief Executive Officer of Rock of Ages also announced the election of seven directors of the Corporation and four officers of Rock of Ages.

Elected officers of Rock of Ages are: George Anderson of Barre, Vice President for Finance & Administration; John Corrigan of Barre, Vice President of Quarries; Jon Gregory of Northfield, VT, Vice President of Granite Products; George Karnedy of Barre, Vice President of Sales & Marketing; Gerald Paquette of Manchester, NH, Vice President; and Kurt Swenson of Hopkinton, NH, President and Chief Executive Officer.

In announcing the acquisition of Rock of Ages, Mr. Swenson said the officers of the firm have more than a century of experience, collectively, in the granite industry.

"Someone asked why we wanted to buy Rock of Ages," he said. "The simple answer is that we think Rock of Ages granite is the finest monumental grade granite in the world. In our one-hundred year history in the granite business, no other member of the Swenson family has every publicly admitted that until today."

Mr. Swenson also said, "We will work hard to expand the market for Barre granite, to minimize price increases and to provide the best service possible to our customers."

The program is being designed to provide sufficient flexibility to allow dealers free time to visit manufacturers or sight-see in the beautiful green mountains of Vermont.





# MBNA CONVENTION

*The Barre Granite Association has long been a very strong supporter of monument retailer associations because they provide an opportunity for memorialists to improve the monument retail business in their state, region and nation.*

Barre granite monuments were purchased in record volume by retailers at the 75th Diamond Jubilee Convention of the Monument Builders of North America in Atlanta, Georgia in early February.

Ten members of the Barre Granite Association were on hand to exhibit their finely crafted granite monuments and many Barre firms reported record sales during the Convention.

The BGA member firms were very pleased, but not surprised with the attraction of their product to the hundreds of retail monument dealers who attended the Convention.





**REWARD FOR SAFETY—  
A ROCK OF AGES PROGRAM**

Imagine being told that your employer is awarding you a gift worth as much as \$250 and you can choose it yourself. Would you take the new camera or the chainsaw, the two sets of skis or the shotgun?

Rock of Ages Corporation recently presented that tempting choice to 29 quarry workers employed at their granite quarries. In addition, nearly 100 Rock of Ages Manufacturing and Quarry workers were each awarded \$50. Sixteen employees were lucky enough to win both the \$250 and the \$50 awards.

Each work group at Rock of Ages earns its award by working safely, being credited for every hour that every person works without injury. The awarding of incentives is operated as a drawing from among the names of all eligible employees.






## A MANUAL FOR CLEANING MONUMENTS

Barre granite is better than other gray granites because of its ability to withstand the penetration of dirt and grime.


The Roberts monument is made of Barre granite. It is nearly seven decades old, and because of its location in the cemetery, near trees and large shrubs, it attracted an accumulation of plant growth and dirt.

All this quickly disappeared, however, when the Roberts



monument was cleaned according to the steps outlined in "Safe Cleaning Procedures for Granite Memorials," a publication of the Barre Granite Association.





## ROADMAP FOR THE FUTURE MASTER PLAN & SECTION DESIGN FOR A SMALL MUNICIPAL CEMETERY


The Town of Bow, New Hampshire realized that the burial space in its cemetery was coming to an end. Through the Barre Granite Association, Grever & Ward, cemetery planners, was commissioned to create a master plan and section design to meet future and immediate on a 6.35 acre site of Evans Cemetery.

With a rather modest annual need for burial space, the new cemetery site was designed for phased development that will permit a new burial section to be added about every 15 to 20 years. As that need occurs, the master plan, with its road system and grading scheme guarantees coordination between present development and each successful future project.

Part of the grading scheme is to deposit surplus burial excavation and other fill in locations where it will best contribute to the next cemetery addition. Other values of the master grading plan are the assurance of proper road grades and positive surface drainage in all parts of the cemetery.

With the master plan the cemetery administrator can plan the use of town equipment on the development as well as making best use of fill as it becomes available from other projects. Both of these factors contribute toward the objective of attractive, salable burial space at a minimum cost. (see plan next page)

■ Phase 1 (Section 1) of Evans Cemetery is planned with very little grade change and with a simple loop road connected to State Road. This section will provide the Town with a 20 year reserve of attractive low-maintenance burial space consisting largely of monumented two-grave lots. Then while Section 1 is being sold, Phase 2 can be filled, graded, turfed and a road installed for its eventual opening around the year 2000.



# Memorial Designs ~




The Huang family memorial was produced by BECK & BECK, INC., for Presbrey-Leland, Inc., of Valhalla, New York. Set in Putnam Cemetery in Greenwich, Connecticut, this majestic memorial is 28-6 x 14-6 x 14-4 overall. The steps, platform, roof stones and urn are made from Guardian Light Barre granite while all other pieces are Guardian Rose granite. Sixty pieces of granite were put together to build this beautiful memorial which features carving on the front and ends and eight, seven-foot-six-inch columns.

This Canadian Pink Granite memorial features a tablet, 2-6 x 1-0 x 2-0, hewn from a rough block with hand axed panel, corners and letters. The balance is a rock finish. The base, 3-2 x 1-6 x 0-10, has a steeled top with the balance a rock finish.




